**Financial Report** – Board reviewed financial report prior to meeting, no questions presented during meeting. Noted unlabeled \$100 was received as a donation from a member for Holiday advertising.

#### 82<sup>nd</sup> Ave Jurisdictional Transfer Business Involvement

Meetings with Nancy, Jacob, and VP of Gov. Affairs of Business Alliance earlier this month. Ensuring businesses have a voice with PBOT, Jon obtained date: October 26th with PBA members and 82<sup>nd</sup> Avenue Business Association, Montavilla and others. Columbia Corridor's Executive Director, Corky Collier, is also invited to attend the meeting. PBOT responded and is pleased to have businesses attend to discuss what PBOT will need input on and what is already decided. Weekly Friday meetings are set to help prepare businesses and ensure agreement prior to October 26th meeting. Next prep meeting is Friday Sept 24<sup>th</sup>

Board voted to attend and set PBOT meeting for October 26th at 3:00pm - All in favor

#### Clean up on September 18th

- Refund will be received for the dumpster that wasn't delivered at previous location
- Involve cartlandia
- Next clean ups on October 23<sup>rd</sup> and November 13<sup>th</sup>: I-84 to Sandy Blvd.
- Nancy ordering weights on Amazon to hold down canopy
- Jacob continuing to tap REED college, hopefully increasing volunteers
- SOLVE recommends scheduling 12 months in advance, and lay out calendar for additional funding
- Jacob proposed board to decide if we continue clean ups in 2022 for next meeting

#### **82 Dishes Progress**

- Reviewed flyer layout, including Chinese version and Spanish Version. Russian version almost done
- Determining if volunteers will walk 82<sup>nd</sup> Ave
- Jacob placing Facebook link to flyers, and including landing page of event
- Increasing participating food sources (not just restaurant and cafes) looking at markets as well for food cooked at home

- Michael to add flyers into mall digital displays (1 pager, enough to read in 5 seconds)
- Individuals to forward business photos to Nancy to add to flyer

### **Suggested Bylaws**

- Goal to vote the following changes by next meeting:
  - 1. Removing "of Roses" from the legal name
  - 2. Expanding area coverage from county line, including all of 82nd Ave in Multnomah County
- Not inviting businesses served in other Business Associations, i.e Foster (unless they request to be added)
- Working toward increasing board diversity and awareness to become stronger voice, seeking food industry involvement
- Bylaws in the revision on next month's meeting, draft will be sent prior to next meeting (2<sup>nd</sup> reading, and approval on October 19<sup>th</sup>)

#### **Venture Portland**

- Working board suggested initiatives included walk and talk tours, pod casts, "Small Business Portland"
- One board member volunteered to coordinate
- We can submit request for topics:
  - 1. Small Business Owners
  - 2. Shopper's perspectives
