Financial Report

\$1,774.80 has been spent from the grant funding. Jacob bought broom sets and Nancy was reimbursed for the dumpster. 82BA purchased the canopy and table from UWS for \$224.97. Nancy was reimbursed \$47.80 for the weights for the canopy. \$50 was sent to the state with the 2021 annual report. The total amount in the account is \$7,621.11. A temporary reallocation of \$1,500 will be taken from the \$3,000 that was reserved for the Rose Gardens and will be replenished in the future.
