The meeting was called to order at 3:02pm, introductions were made. Quorum was established. Meeting Minutes from Jan. 14th meeting were unavailable to approve at the time of the meeting. Financial Report

Lori presented the financials. Jacob suggested an updated spreadsheet of paid members be created. Nancy reported that *Ocean City* paid dues as did Jay Patel at *Econolodge* who added a \$250 sponsorship. *Todd's Point S* membership also came in yesterday.

Nick Falbo & Gena Gastaldi spoke about a new *PBOT* program born out of the safe streets initiative project that began during the pandemic. He asked the group to help identify possible sites and locations in and around 82nd Avenue. Nick will send the presentation. Nick then took questions. Montavilla will have its square on 79th again. Nancy suggested Pine Street near the *St Peters & Paul Episcopal Church* and the site was discussed. One question, especially for 82nd Avenue is a matter of safety; Jacob asked if it might be possible for 82nd Ave streets to use concrete planters instead. Quincy Brown discussed a project N of Division and 86th that he worked on with *APANO* and the *Jade District*.

Quincy Brown with *We All Rise* presented information about the 79th & Glisan Housing project. This is a community based, local affordable housing project. *Related Northwest* is the developer with partnerships from *IRCO, Catholic Charities, Mercy Corps NW, PDX Urban Gardens*, as well as many others. The project expects to be able to receive tenants by 2024. Focus groups will be forming in March and future community open houses are being planned to begin in April. Quincy took questions. Quincy offered to circle back with the board to talk more about potential properties on 82nd Ave as well as the plaza concept

Old Business
